## **JUROR INFORMATION SHEET**

Thank you for serving as a Mobile County Circuit Court juror. Below is important information that we hope will be helpful to you during your jury service.

**\*NOTE: YOUR PANEL NUMBER AND YOUR JUROR CALL IN NUMBER ARE VERY IMPORTANT! PLEASE WRITE THEM DOWN! YOU WILL NEED THEM ALL WEEK!**

### **JURY LOUNGE**

As a juror, you are allowed to bring food and drink into the courthouse in a closed container. There is a jury lounge located on the 8<sup>th</sup> floor for juror use. There are tables and vending machines in the lounge. We do not have a microwave or refrigerator. If you are called back for jury service, we will have complimentary coffee in the jury lounge each day for you.

### **ARRIVAL AND ELEVATORS**

We ask that you arrive at the courthouse 15 minutes prior to your report time as elevators are often crowded.

### **PARKING**

The court does not validate parking or reimburse for parking or parking tickets. There are numerous parking lots available to jurors at varying rates. PARKING ON THE STREET IS NOT ADVISED AND IS AT YOUR OWN RISK. You may not leave jury service to feed a meter.

### **JUROR PAY AND WORK CERTIFICATES**

State law sets jury fees. Juror payment is \$25.00/day plus \$.625 a mile (round trip). We will do our very best to provide you with your check and work certificate prior to releasing you from jury service. If that is not possible, we will place your check and work certificate in the mail to you the very next morning.

Please note: an Alabama employer is legally responsible for paying a full-time employee's regular wages while in service as a juror.

### **JURY PROCESS**

We have 8 Circuit Judges who hear jury trials each jury term. Some judges will hear civil cases and some criminal.

We utilize a juror call-in phone system to inform jurors of when they need to return each day for jury duty. This allows us to only call back a certain number of jurors that are needed each day.

### **CALL IN JUROR LINE**

Generally jury service is for a one-week term. No cases are scheduled to begin on a Friday. Your jury service will end after Thursday unless you are serving as a juror on a case that will continue into Friday. In some rare instances, cases may last longer than a week.

As a juror if you are not sitting on a jury trial, you should call the number provided to you by Court Administration or the Judge's office each night after 5pm. The number will contain a recorded message that will tell you based on your panel number whether you need to report the next day. It will also provide you with a time and a location to report. If you call the recorded message and your panel number is not called back for the next day, you should report to work because your work certificate will show exactly what days you were with us. If you are a night shift worker (i.e. a nurse working a 7am-7pm shift), please notify Court Administration immediately for specific reporting instructions!

You will continue to call the number each night after 5pm until you serve as a trial juror in a case and/or until you are advised that you have been RELEASED for the week from jury duty.

Should there be a system failure and you are unable to retrieve the recorded message, YOU SHOULD REPORT TO JURY DUTY AT 9:00 a.m. IN JURY ASSEMBLY on the 8th floor the following day.

### **EMERGENCIES**

If you have a true emergency and are unable to come back and serve as a juror, you should immediately contact Court Administration at 251-574-8603 to let us know of the emergency. If we do not answer, please leave a detailed message with your full name, panel number, details of your issue and a good telephone number to return your call. Please note that we will require documentation to excuse you (i.e. doctor's note, invoice from flat tire or wrecker service)
